

### VISTA ROYALE ASSOCIATION INSTRUCTIONS

#### Application/Registration - RENTAL

- 1. The Application/Registration Form must be submitted using the Association's approved form 30 days prior to start of lease.
- 2. A copy of the fully executed lease must be provided with the application/registration.
- 3. The Application/Registration must be filled out legibly and completely, and signed by all applicants, and owners.
  - a. All blanks must be filled in.
  - b. Page 2: Every applicant's signature is required following animal restrictions and acknowledging having read the Rules and Regulations Handbook.
  - c. Page 3: Owner's signature is required.
- 4. Legible copies of identification (ID) for all applicants and residents must be provided. Acceptable forms of ID include:
  - a. Driver's License. Faxed copies are not readable, therefore not acceptable.
  - b. Passport
  - c. Immigration card
  - d. Military Identification
  - e. Any state, local, national or international documentation, provided it contains information about the age or birth of the possessor
  - f. Birth certificate may be presented provided the name on the certificate matches the name of the applicant. If name has been legally changed, then proof of the legal name change or additional documentation must also be provided to verify that the person listed on the certificate is the applicant.
- 5. A legible photograph or legible copy of photograph, suitable for visual identification purposes, must be provided for all applicants.
